**NOTICE OF THE ADOPTION OF AN OFFICIAL PLAN FOR THE CITY OF KENORA  
UNDER SECTION 17(23) OF THE PLANNING ACT, RSO 1990**

**TAKE NOTICE** that on May 17, 2010, the Council of the Corporation of the City of Kenora adopted The City of Kenora Official Plan under Section 17 of the Planning Act, as amended.

**Purpose:** The purpose of the City of Kenora Official Plan is to establish a vision, guiding principles, objectives, and policies to manage and direct physical development and the effect of change on the social, cultural, economic, and natural environment for the twenty (20) year planning horizon (i.e. until the year 2031).

The policies, together with any land use and Schedule(s) and any amendment(s), which are adopted and finalized pursuant to the Planning Act, constitute the Official Plan of the City of Kenora.

**Effect:** The Kenora Official Plan provides direction in how the City should position itself for its future through specific guidance for developing a lifestyle, sustainable community for future generations to enjoy. The policies and Schedule "A" contained herein are established primarily to guide the physical development of the City while having regard to the relevant social, cultural, economic and natural environmental matters.

**Location:** A key map has not been provided because the Official Plan applies to all lands located within the City of Kenora.

**Approval Authority:** The Ministry of Municipal Affairs and Housing is the approval authority for the Official Plan for the City of Kenora. Any person or public body will be entitled to receive notice of the decision of the approval authority if a written request to be notified of the decision (including the person's or public body's address) is made to the approval authority. It is also available on the City's portal [www.kenora.ca](http://www.kenora.ca). The Subject Lands are also the subject, under The Planning Act, of a Comprehensive Zoning By-law review and consolidation of Zoning By-laws 160-2004 of the City of Kenora. A copy of the By-law to adopt the new Official Plan is available at the Clerk's Department at City Hall.
